Your Charitable Endowment

Leaving a charitable bequest in a will often enables individuals to make a very generous gift to causes that matter to them and their families. There are also significant tax savings that can be realized for the estate. Donations made in both the year of death and under the individual's will can be claimed in the year of death and, if necessary, carried back to the preceding year. The 100% net income limitation applies to both the year of death and the preceding year. The donation credit also applies to gifts of RRSPs, RRIFs and life insurance proceeds.

Partnering with The Canadian Foundation for Animal-Assisted Support Services by naming us as the beneficiary of these legacies will ensure that your gifts will help, not just one charity, but charities across Canada, and those they serve.

Following is an example of language that can be used in a will to direct bequests to The Canadian Foundation for Animal-Assisted Support Services.

Sample Language

Pay or transfer the residue of my estate to The Canadian Foundation for Animal-Assisted Support Services, charitable registration number 870159043 RR0001. It is my wish that the Board of Directors at The Canadian Foundation for Animal-Assisted Support Services, in their absolute discretion, direct this gift as an endowment gift for

the Foundation and apply monies on an annual basis from the endowment gift in the Foundation Account to charitable organizations that e.g. train service dogs, provide therapeutic riding, support the welfare of animals in service, support Canada, troops, first responders and their families, etc.
